



THIRD REGIMENT FACT SHEET

WHAT: The Third Regiment Incorporated is a historical education organization dedicated to the preservation of the memories of the soldiers who served in the armies of the American Civil War. Member organizations and individuals thereof participate in a wide variety of public and private educational events including, but not limited to, encampments, parades, battle recreations, public speaking appearances, and related historical-themed events.

WHEN: The Third Regiment was created in November 2024 and saw its first field service in 2025.

GOVERNANCE: The Third Regiment is governed by an Executive Board as elected by the member units. A set of Bylaws have been created and approved by the membership. The current Executive Board – elected annually for a 1-year term - are the following individuals:

LEGAL STATUS: The Third Regiment is a registered 501(c)(3) education corporation in the state of Pennsylvania.

DUES: Initial Third Regiment Dues are \$200 per member Company. These dues are to a) Insure the Regiment and its member units (\$1M liability policy in place) and b) Fund the organizational website (www.ThirdRegiment.org). Subsequent dues amount are set by the member units based on an analysis of operating costs for the upcoming year. (2026 Dues for existing members was set at \$140.)

PHILOSOPHY: The Third Regiment is a flat and lean organization that focuses on maximizing the positive experiences of member Companies. The Executive Board exists only to facilitate the activities desired by Member units. Overhead activities will be kept to a minimum – e.g.: no scholarships, dances, dinners, etc. that have inflated the costs of similar organizations. The watchwords of Executive Board are “Transparency” and “Servant Leadership.”

The Executive Board and the Military Command structure will be kept separate save for the overlap of the position of the Military Commander.

Lastly, Member organizations of the Third Regiment are committed to working together at events in an inclusive fashion.

JOINING THE THIRD REGIMENT: The Third Regiment is open to new member units who share the goals and philosophy of the Regiment.
